- 5. Consultants may associate with other consultants to enhance their qualifications.
- Expressions of interest shall be delivered online through e-GP system <a href="https://bolpatra.gov.np/egp">https://bolpatra.gov.np/egp</a> to the address Department of Land Reform and Management, Babar Mahal, Kathmandu, Nepal on or before 13:00 hours, May 9, 2018.
- 7. Expressions of interest shall be opened in presence of Bidders' representatives who choose to attend on 14:00 hours, May 9, 2018 at the office of Department of Land Reform and Management, Babarmahal, Kathmandu, Nepal.
- 8. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
- 9. EOI will be assessed based on Qualification 30%, Experience 60%, and Capacity 10% of consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a request for proposal.
- 10. Minimum score to pass the EOI is 70.
